A HOMELESS MOTHER'S JOURNEY FROM SHELTER TO SUSTAINABLE HOUSING AND WORKING FULL-TIME:

This testimonial highlights the our partnerships and interaction of various shelter programs and how each one in the community provides a need at the critical times during the homeless journey toward sustainable housing.



I entered the emergency family shelter program in April of 2016 with my children who are 8 and 13. Both go to school in Frederick County. While I was in the Emergency Family Shelter, I was connected with an English tutor from the Literacy Council and applied for transitional shelter through the Frederick Community Action Agency. After about a month at the family shelter, I was transitioned into the transitional shelter at FCCA that I applied for. This month (June 2017), I will be moving into a transitional shelter apartment through Advocated for Homeless. This is one step closer to moving my family into my own house.



In 2016 we served **4,400** unique individuals all of whom are homeless and/or very low-income, living 200% below Federal Poverty Levels.
